ALC GENERAL POLICIES

General Information and Policies Agreement

I have received and been briefed on the ALC Parent/Student Handbook. I understand the ALC, as a CFISD program, adheres to the CFISD Student Code of Conduct. No Trespassing Agreement: Warning to Student

Acceptable Computer Use

The use of our district's computer technology is a privilege intended for instructional purposes. Use of these computer resources is restricted to students working under a teacher's supervision and for approved instructional purposes only. Violations of this Acceptable Use Policy may result in withdrawal of privileges or other disciplinary action.

Dress Code Agreement with Student

Behavior Contract with Student

The Texas Education Code Section 21.031 as Amended September 1, 1983 provides that:
